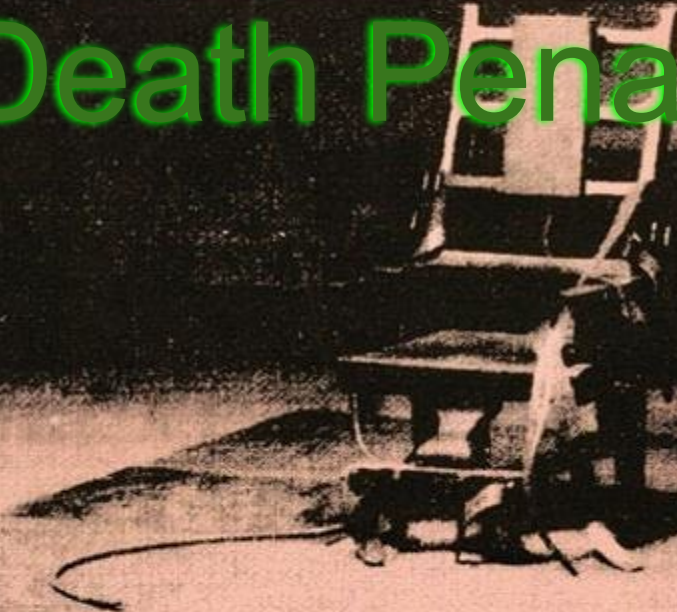


# UVU Students Views About the Death Penalty

# Procedure of our research

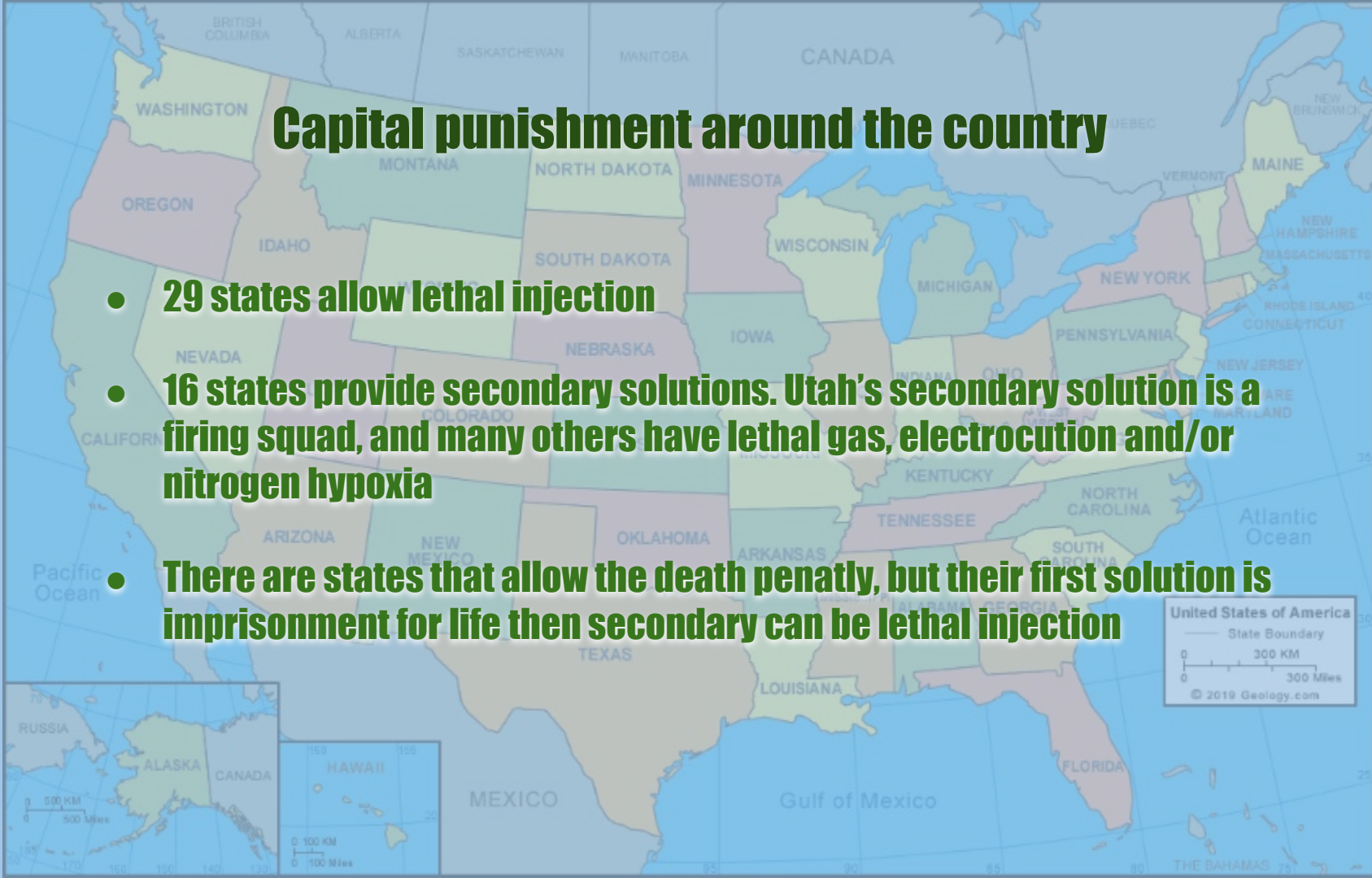
- First we researched if this has ever been done before
  - We looked at the general populations opinions on the death penalty, and if it was thought to be ethical or not according to the general public
- We decided we wanted to distribute it to current UVU students to get the most relevant data.
- 500 subjects (students) were provided by the IRI
- 83 responded to our survey
- Time: Data was taken for a period for 2 weeks
- Once we got our data back we compiled it into easily understandable graphs

# **The Purpose of our Survey**

- **What is the perspective of the student body of UVU when it comes to capital punishment?**
- **Does ethics when considering human mortality change with generations?**
- **Do these results give us an idea of what the future could hold regarding change in laws of capital punishment?**
- **Will our survey change the participant's perspective on capital punishment?**

# Capital punishment around the country

- 29 states allow lethal injection
- 16 states provide secondary solutions. Utah's secondary solution is a firing squad, and many others have lethal gas, electrocution and/or nitrogen hypoxia
- There are states that allow the death penalty, but their first solution is imprisonment for life then secondary can be lethal injection

- **39%** say they are opposed <sup>(1)</sup>

Do not support capital punishment

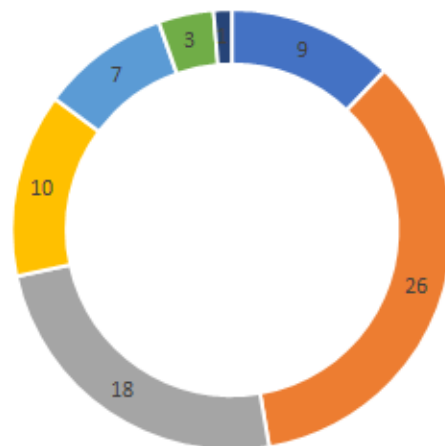

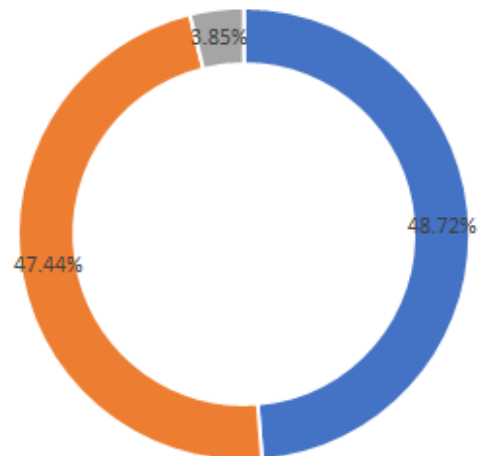

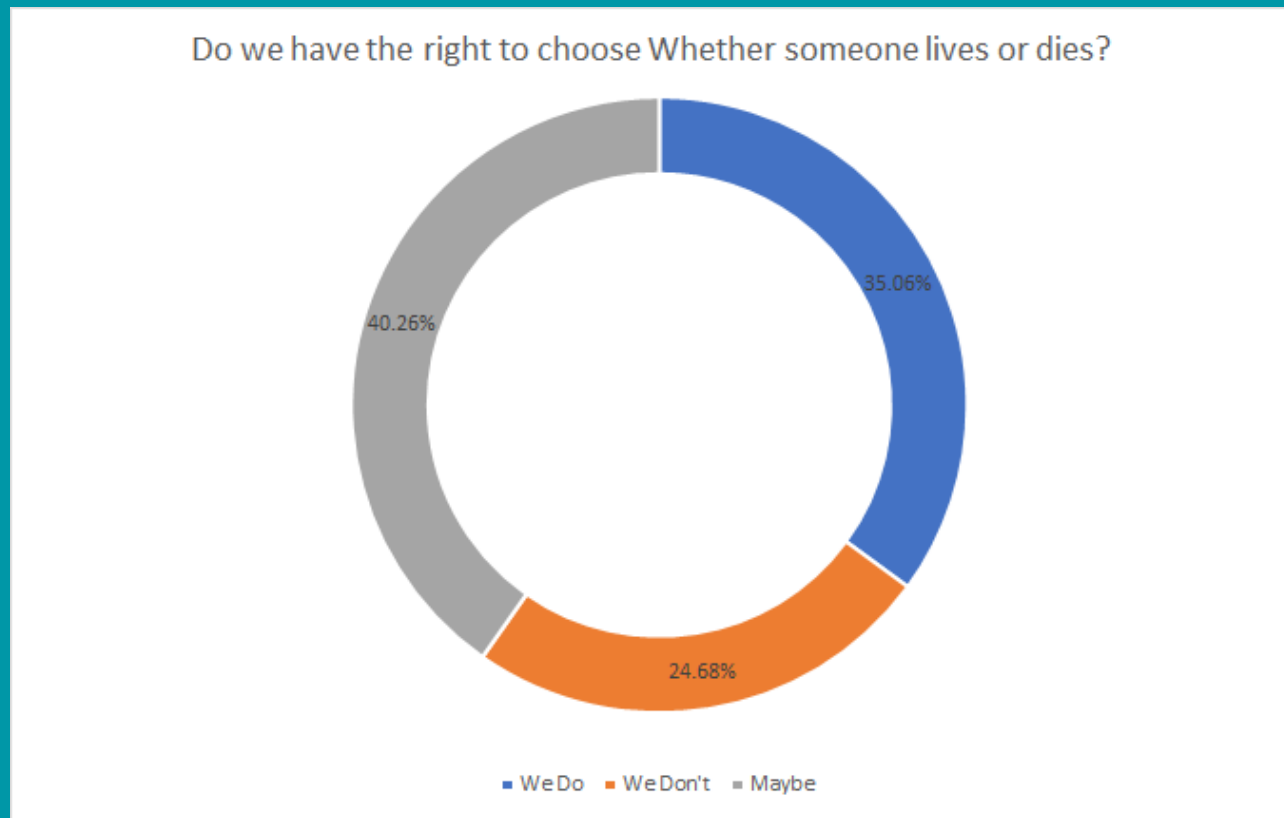

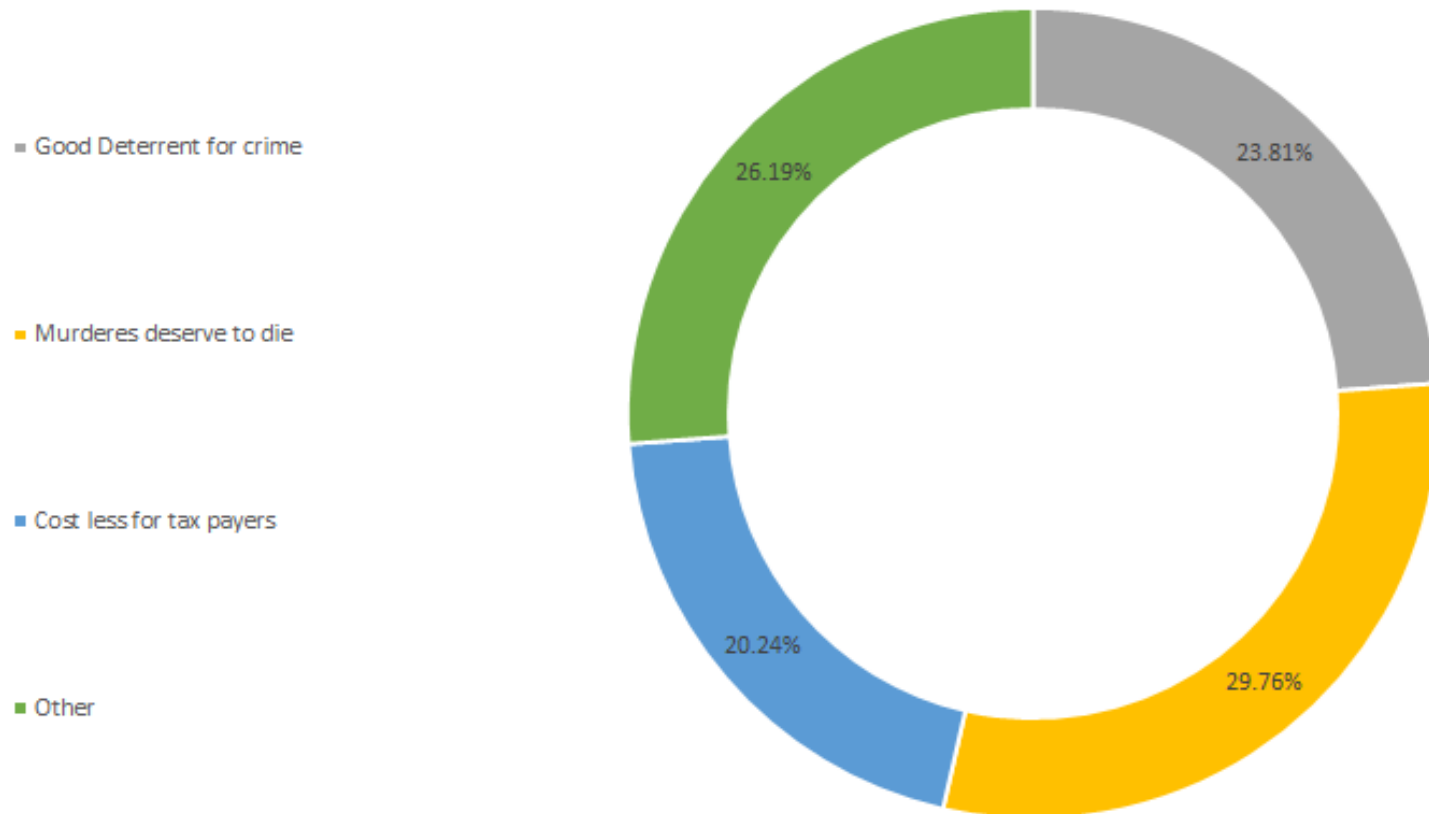


Do we have the right to choose whether someone lives or dies?





## What are some reasons you do support capital punishment



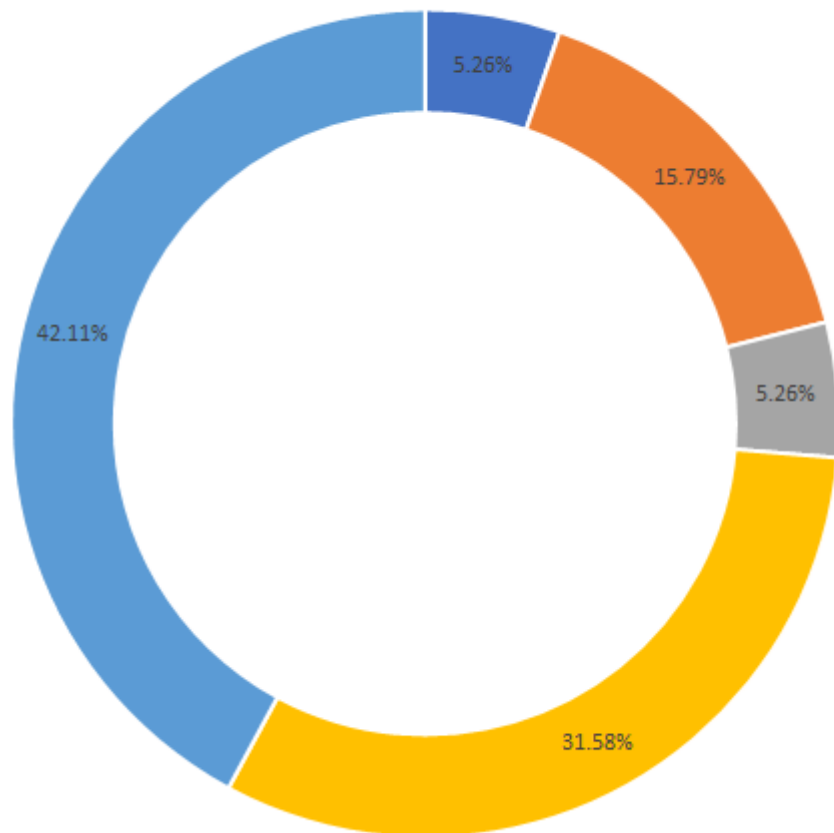
# Others explained out of 21 responses...

- other

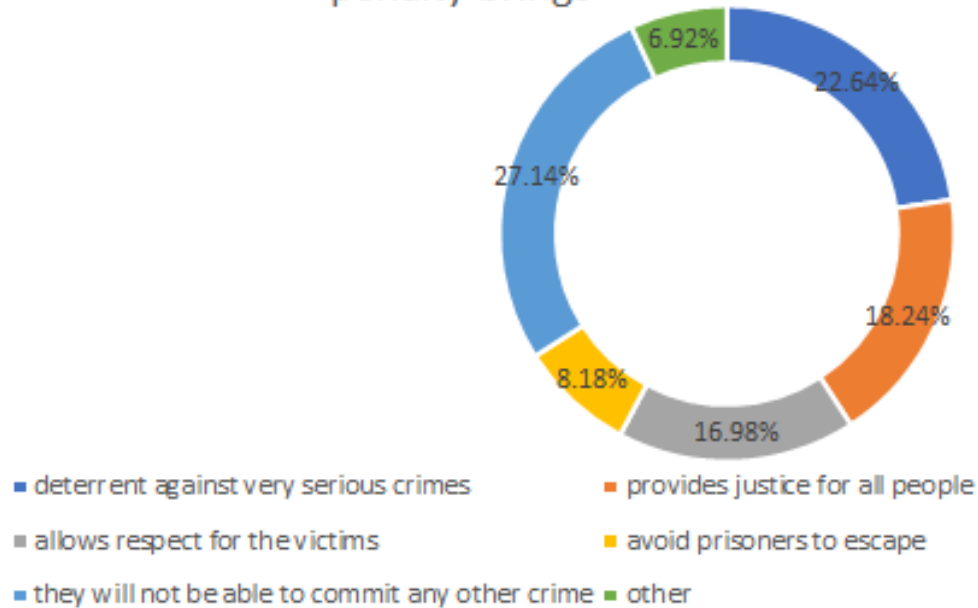


## Others explained out of 8 responses...

- (3) All of the above



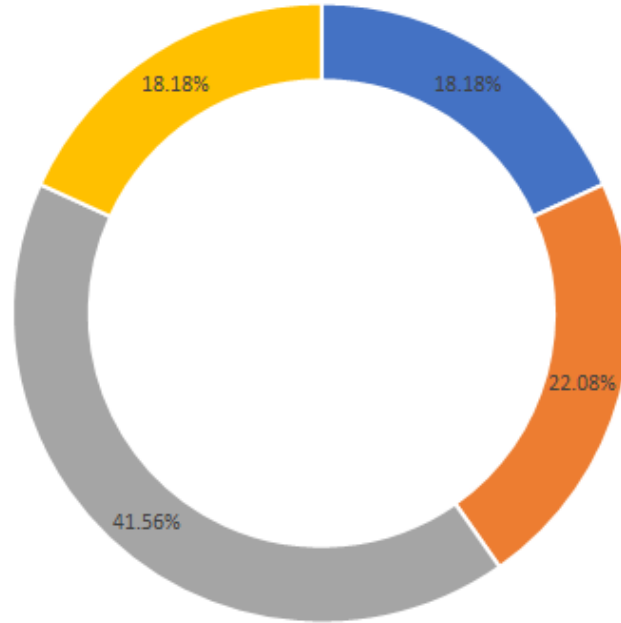
Please explain some of the benefits you believe the death penalty brings

If someone sentenced to the death penalty dies but is later found to be innocent what do you suggest should be done?



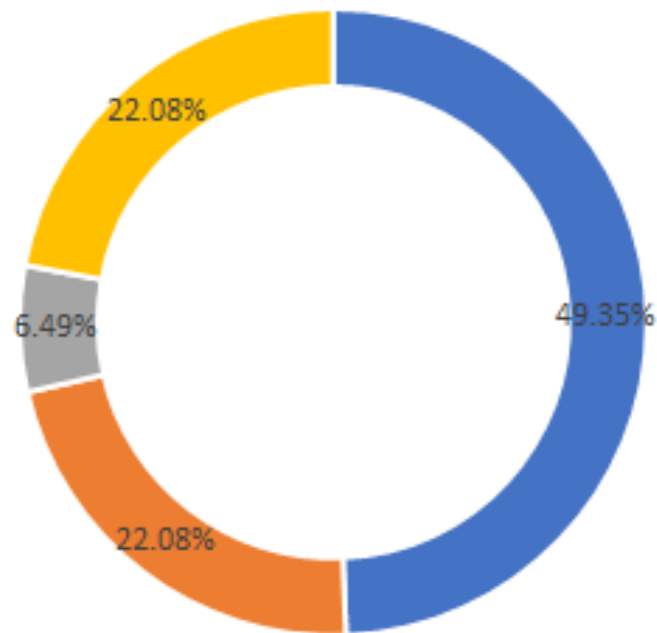

After being sentenced to death and all the appeals have been denied, how long should a criminal have to wait before he/she is executed?



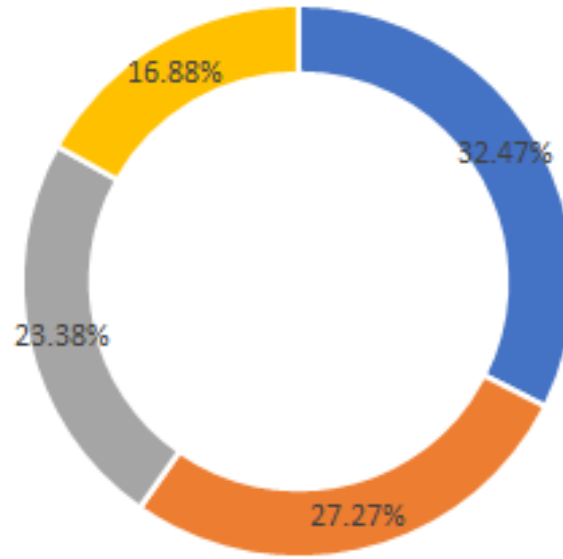

Does it go against a person's 8th amendment rights, against "cruel and unusual punishment", to make a person wait in death row for a long time?



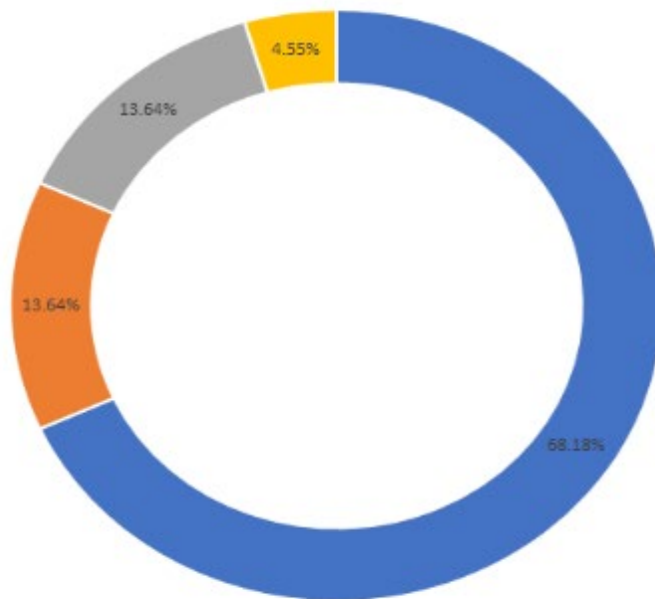

What alternatives would you recommend for criminals if you do not support capital punishment?

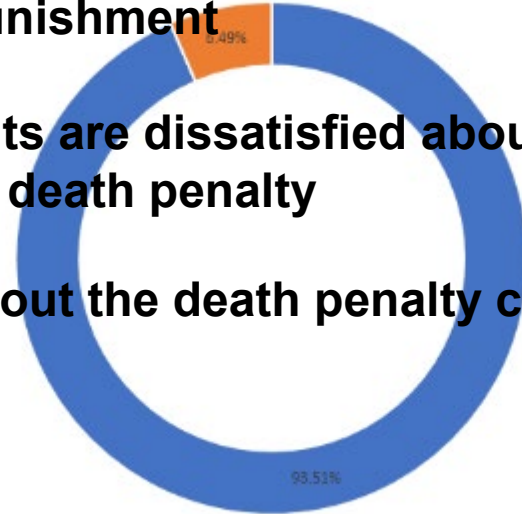

# What we Learned

- It is important to know if the opinions of UVU students as it can reflect the general public's opinion about capital punishment



# What we could have done better

- We could have asked them what race they were to get more information
- Asked their religious beliefs, or if their opinions came outside of their religion
- If we had asked where they lived, it could have helped to explain their views
- Looking back we should have asked them if they thought that the death penalty was even an issue. If we had asked this we could have filtered the questions, so that we might not have ended up with so many Others, and no contests
- If we asked them what political party they belonged to, it would have helped us organize our data and it could have explained some of the choices that people made
- We could have focused more questions on juveniles and if capital punishment should be applied to them
